## Quality Monitoring

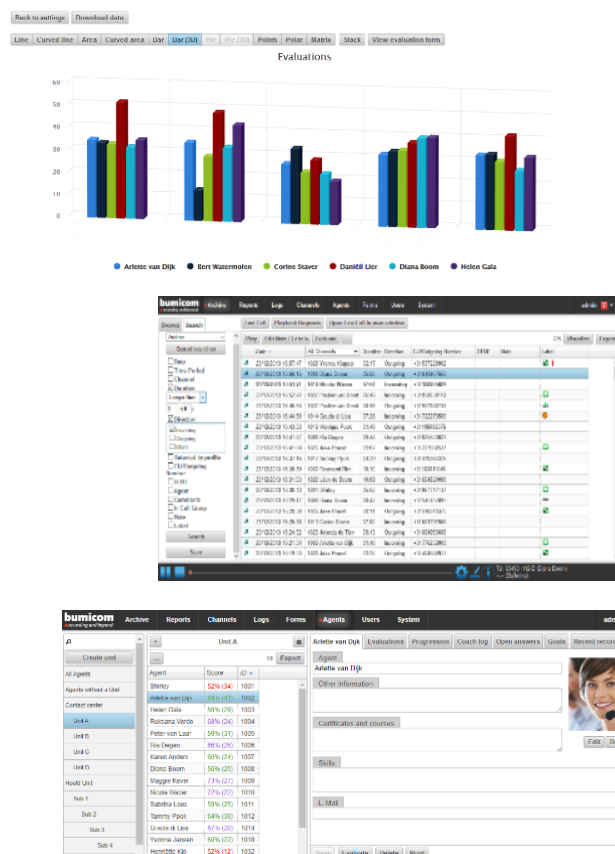

## Storage capacity

The capacity of storage is available in different packages from 1GB, depending on recording volume and retention times. Standard storage capacities 1GB, 10GB, 100GB, 250GB, 500GB, 1TB, 2TB, 5TB and 10TB. Custom storage plans are possible.

## Retention time

A deletion time can be determined within a recording rule, so that the data will be deleted once the retention time is reached.
